February 3, 2026 6:30 p.m.

The Roachdale Town Council held a special meeting on Tuesday, February 3, 2026 6:30 p.m. at the Roachdale Community Building, 204 N Indiana Street, Roachdale, Indiana.

President Amanda Newcomer called the meeting to order after recognizing that the agenda was posted pursuant to the Indiana Open Door Law and that a quorum was present. President Amanda Newcomer stated that the meeting is being livestreamed and would be available on the Town website and YouTube.

1. Stormwater Project

A. Preliminary Contract

Motion by Zach Bowers, second by Paul Wireman, vote unanimous, to approve the HWC Memorandum of Agreement for Engineering Services in the amount of \$4,500.

B. OCRA Timeline- Mike Kleinpeter, Kleinpeter Consulting, presented and discussed the OCRA Construction Grant Timeline for Round 1-2026 for the project and stated the proposal must be 95% complete by March 27, 2026.

President Amanda Newcomer asked if HWC would have any issues meeting the timeline and Eric Smith stated that they would not.

Mike Kleinpeter stated that HWC has worked on multiple projects before.

2. Old Business

Motion by Zach Bowers, second by Paul Wireman, vote unanimous, to suspend rules of 2<sup>nd</sup> and 3<sup>rd</sup> readings and to pass Ordinance 02-2026 on second and 3<sup>rd</sup> readings.

3. New Business

- A. Town Marshal Position – President Amanda Newcomer stated that the Council had received notice from Marshal Adrian Lepine that his last day would be February 8, 2026. Motion by Zach Bowers, second by Paul Wireman, vote unanimous, to accept Marshal Adrian Lepine’s resignation effective February 8, 2026.

Motion by Zach Bowers to amend his motion to include motion to pay out vacation time only with Marshal Lepine's final pay, motion seconded by Paul Wireman, vote unanimous.

Motion by President Amanda Newcomer, second by Zach Bowers, vote unanimous, to keep Adrian Lepine on as an unpaid reserve.

- B. Cole Long Gas Certification – President Amanda Newcomer stated Cole Long passed his gas certification on February 2, 2026.

Motion by President Amanda Newcomer, second Paul Wireman, vote unanimous, to pay \$1 extra an hour with hours effective February 2, 2026 for his gas certification.
