The Roachdale Town Council held a special meeting on Monday, December 30, 2024, 6:51 p.m. at the Roachdale Community Building, 204 N Indiana Street, Roachdale, Indiana.

President Zach Bowers called the meeting to order after recognizing that the agenda was posted pursuant to the Indiana Open Door Law and that a quorum was present.

1. Old Business

A. Police Vehicles – President Zach Bowers stated JTN is working on a quote for upfitting the second 2024 Tahoe with lights and other associated equipment but it is not yet finalized. Interim Marshal Tash stated that it should be available within the next week and will be cheaper than the quote that was approved for the first Tahoe in the amount of \$21,442.70 due to the second vehicle not having any associated K9 equipment.

Motion by President Zach Bowers, second by Paul Wireman, vote unanimous, to approve JTN to complete the upfitting of the second Tahoe, in an amount not to exceed \$21,442.80, pending receipt of the official quote.

President Zach presented a quote from Shadow Graphix in the amount of \$710 per vehicle with a note that it is a rough estimate with a 10% margin with final cost depending on measurements of vehicle. President Zach Bowers stated that Interim Marshal Tash stated that Detailed Dreams would undercut the quote but wanted 50% upfront and 50% at completion and the Council did not agree to that.

Motion by President Zach Bowers, second by Paul Wireman, vote unanimous, to approve the quote from Shadow Graphix at an amount not to exceed \$1600 for both vehicles. Amanda Newcomer asked if the Tahoe is back and Debbie stated it will be picked up next week. Paul Wireman asked if the light bar was ready and Debbie stated that it was.

B. 2025 Salary Ordinance - President Zach Bowers stated that as part of the 2025 Salary Ordinance all employees that worked in 2024 would be receiving a bonus. President Zach Bowers stated that starting today Bryson Tash will go back to \$25 per hour. Motion by Paul Wireman, second by Amanda Newcomer, Zach Bowers against, motion passed, to approve Salary Ordinance 2024 as presented. President Zach Bowers asked for Debbie to do a roll call vote for the 2024 Salary Ordinance. Debbie asked for the roll call on the 2024 Salary Ordinance President Zach Bowers no, Paul Wireman yes, Amanda Newcomer yes.

- Clerk-Treasurer Items Debbie stated that there is still a problem with an odor in the
 Community Building and she continues to have a concern with the lift station and will ask Troy
 Elless for his opinion. Debbie reported that Trane has indicated that the issue with the furnace
 in the large room at the Community Building is due to an issue with Duke so they are going to be
 contacted about the issue.
