


## Board Meeting Minutes for July 8, 2014


1. BOARD MINUTES APPROVED– June 2, 2014  
Present at the meeting were Council members Barbara Scott and J. Zachary Bowers and Deputy Clerk April Bradley
2. GUESTS – Tammy Folck, Joe Buser, Brian Lathrop, Larry Kersey, Tina Gurney, Roberta Albright. Tammy Folck stated that she received \$560 from the auction and \$200 had been donated. Joe Buser stated that the concert would be on Sunday, June 22<sup>nd</sup> and that the movie would be filmed on June 25<sup>th</sup> and 26<sup>th</sup>. Larry Kersey wants the Harrison's dog to stop pooping in his yard. Town Marshal, Mike Mahoy would give them a nuisance warning. Tina Gurney said that she was given trees for the Park and wanted a blue print of the Park. Ms. Gurney was told to call 811. Roberta Albright wanted to be reimbursed for mowing 7 N Indiana St.; she was told she would have to call realtor or the bank that owns the property.

8. TOWN EMPLOYEES – Greg Poole gave an update on the Water project and that everything was going very well and that the IURC was here for an Audit. Clint Anglin stated that the lift station rehabilitation would be starting June 3<sup>rd</sup>.
9. LYKINS – The payment application for Lykins was approved.
