

## Board Meeting Minutes for March 11, 2014


1. BOARD MINUTES APPROVED– February 11, 2014  
Present at the meeting were Council members Barbara A. Scott, Jackie R. Jones, and J. Zachary Bowers, Town Attorney David Peebles, and Clerk-Treasurer Martha Louk
2. GUESTS – Holly Corbin, Jim Cromwell, Tammy Folck, and Kyle from the Banner Graphic. Holly Corbin wanted to know if it is alright for the Delts to host the 5k run again during Summer fest. Tammy Folck talked to the Council about a Cardinal Health Grant from Eli Lilly, having an Auction the first week of May, and having a Park Board.
3. RELEASE OF FUNDS/PERMISSION TO SIGN CONTRACT – Council members unanimously voted to have Council President Barbara Scott sign the release of funds and contract for the water project.
4. BUILDING PERMIT – Council members unanimously approved building permits for Robert Clampitt and the Baptist Church.
5. CLOTHING ALLOWANCE – Council members unanimously approved a clothing allowance for Utility workers, Full Time will have \$500 and Part Time will have \$250 a year.
6. TOWN MARSHAL MIKE MAHOY – Was not at the meeting due to being called to duty.
7. TOWN EMPLOYEES – Greg Poole stated that the roof at the water plant was leaking and had two estimates one from Rockville roofing in the amount of \$1500 and another from Jeffries in the amount of \$1750. Council members unanimously approved the quote from Rockville roofing. Jason Woodall had nothing to report and Clint Anglin had nothing to report.


Barbara Scott brought up property clean ups. Council members unanimously decided to have Town Marshal Mike Mahoy serve nuisance tickets to Shelia Williams for the property located at 302 E Columbia and to Ruby Bell for the property located at 102 W Railroad. Council members also unanimously approved to have Town Attorney David Peebles send an Unsafe Building notice to the owners of 405 E Washington St.

MEETING ADJOURNED – Council member Zach Bowers made a motion to adjourn the meeting and Barbara Scott seconded the motion.


